Dear Mr. Peters:

As we reviewed the first draft of the audit three things stuck out to me that I feel would be worth explaining in an effort to facilitate the understanding of the difference in the financial statements that we have been presenting vs. what has been presented in the audit. The three items can best be summarized as: 1) Cash vs. Accrual Accounting; 2) Suntrust Cash Balance; 3) Outstanding Accounts Receivable. The differences noted are for explanation purposes only and are not intended to be relied upon as a management representation letter about the audit and should not be relied upon for assurance purposes.

### **Cash vs. Accrual Accounting:**

Under cash basis accounting, revenues are recognized when cash is received and expenses are recognized when cash is paid out. As a result of this type of accounting method there is no way to account for any accounts receivable or any accounts payable that the organization may have.

In contrast, under accrual basis accounting revenue is recognized when the revenue is earned and expenses are recognized in the same period revenue is recognized. Below are a few of the major differences on the Profit and Loss statement as well as the Balance Sheet:

- Cash Net Income is \$-120,140.96 vs. Accrual Net Income is \$71,384.48, this is primarily due to adding outstanding QARA revenue that was previously maintained on excel.
- Cash Revenue is \$1,807,492.20 vs. Accrual Revenue is \$2,000,750.84, which again is attributed to the QARA revenue that was previously maintained on excel.
- Cash Expense is \$1,927,633.86 vs. Accrual Expense is \$1,929,366.36, the minor difference is due to the fact all bills are paid immediately upon receipt.
- Cash Accounts Receivable is \$0.00 vs. Accrual Accounts Receivable is \$181,651.64, which again is attributed to the QARA revenue that was previously maintained on excel.
- Cash Accounts Payable is \$0.00 vs. Accrual Accounts Payable is \$-41,176.53, this was a carryover from the prior year of bills that were outstanding but not paid as of year end.

### **Suntrust Balance:**

- The bank balance at 12/31/14 was \$183,321.89 and the QuickBooks bank balance at 12/31/14 was \$144,522.39.

The difference is attributed to the outstanding checks that were issued before year end and not cashed until after the new year as well as deposits that were made at year end but not credited by the bank until after the new year. This accounted for a \$38,799.50 difference.

**Outstanding Accounts Receivable:**

- The Accounts Receivable balance on a cash basis was \$0.00 but on accrual basis the account balance was \$181,651.64.


The decision was made in 2014 to start accounting for all revenue that was happening within the organization which included outstanding QARA surveys. At the time this decision was made the outstanding QARA invoices were maintained on an excel spreadsheet separate from QuickBooks. As new revenue came into the organization and new surveys were being scheduled we started to record that upcoming revenue in an effort to show the actual activities of the organization and not keep a separate set of books that accounted for QARA revenue. As a result this left a difference in the amount of revenue that was received vs. what was still outstanding but has not yet been received.

In conclusion, we attribute these differences to the transition in accounting method from a modified cash basis to accrual basis. I'm sure there will be more questions so if we can be of any further assistance please don't hesitate to contact me directly.
